A few quick privacy reminders!

- Always be sure to manually encrypt emails containing Protected Health Information (PHI) when sending externally to non-UF addresses (ex. Gmail, yahoo, Hotmail, etc.). Instructions for adding email encryption are located at <u>Email</u> <u>Encryption - GatorMail - University of Florida</u> (ufl.edu).
- Immediately report any suspected or known privacy violations to UF's Privacy Office using any of the following methods:
