Summer Seminar Series: Research Integrity and the Responsible Conduct of Research

In the Summer of 2020, UF Research Integrity in collaboration with RCR on Campus hosted its inaugural seminar series on Research Integrity and the Responsible Conduct of Research (RCR). The series included 22 classes and covered a wide variety of topics including the research lifecycle, research misconduct, peer review and authorship. Over 300 students, faculty and staff participated in the courses and over 120 earned the RCR certificate, satisfying NSF and USDA RCR requirements. Clery Act Compliance

Campus Security Authorities (CSAs) Annual Training


At the University of Florida, maintaining a warm and welcoming campus environment is one of our highest priorities. Campus Security Authorities (CSAs) are a vital part of our institutional effort in working together for safe campuses. CSAs are mandated reporting parties under the Clery Act. At UF, they are notified of their designation upon assuming their role and on an annual basis thereafter. CSAs are required to participate in training on an annual basis. All communication and reminders of the training will be sent to CSAs from the Office of Clery Act Compliance and Human Resources. Campus Security Authority training is available in the University of Florida's MyTraining online platform. The training must be taken via the MyTraining system in order to receive credit for participation.

ASK YOUR COMPLIANCE OFFICER!

Question: We would like to hold a fundraiser for a popular youth program that would benefit under-privileged families in the community. We would give each person who makes a donation a ticket and then have a prize drawing. Is this OK?

Answer: No, it is not. In general, Florida law prohibits drawings by chance like the raffle-type incentives you describe, unless the organization holding the drawing falls into a limited exception. That exception is focused on 501(c)(3) tax exempt organizations, which the University of Florida is not.
