

Ethical dilemmas are present in all walks of life. Effectively responding to these types of challenging situations is often difficult and complex. The ethical dilemmas we commonly face in higher education are no exception. Effectively dealing with these challenges requires the ability to address issues from both sides, think critically, and arrive at a course of action based on sound analysis. Stumbling blocks in this arena include personal biases and reasoning errors that can cloud our perspectives and adversely impact the persuasiveness of our oral or written arguments.

# ASK YOUR COMPLIANCE OFFICER!

**Question:** Aren't Compliance and Ethics the same thing? What's the difference? **Answer:** Compliance means following laws, rules, and policies. However, Ethics is about doing what is right, even when there are no laws, rules, or policies to follow. Breaking a promise or lying to a coworker may not be breaking any laws, but it could be considered unethical, particularly if it has an impact on the working relationship or office productivity. Conversely, while it may seem ethical to help a young neighbor with a fundraiser for a worthy cause by asking coworkers to contribute to the effort, UF has a no-solicitation policy that prohibits such activity in the workplace.
